### NOTES

- 1. A Demolition Permit is valid for one hundred eighty (180) days from the date of issuance.
- 2. A Street Cleaning deposit is required for any work involving hauling material or other items to or from the subject site.
- 3. Any soil contamination shall be cleaned up and addressed prior to the start of demolition or the use of the property. Washington State Department of Ecology approval may be required.
- 4. Any stormwater catch basins on site will have filter fabric placed in the grate prior to the start of demolition.
- 5. An inspection is required prior demolition and prior to any backfilling on site and for the start of demolition work on the building or structure. No work will be covered prior to inspection and the permit is signed showing approval. It is the duty and responsibility of the owner / contractor to see that all work remains accessible and exposed for construction purposes until approved.
- 6. After demolition is complete, all debris (including but not limited to construction materials, vehicles, yard waste, parts, appliances, damaged vegetation and trees, etc.) shall be cleared and removed from the site. The demolition site shall be left in a clean state. BMPs for erosion control shall be provided and approved by Public Works.
